# Comments on the Consultation Document of the New Agriculture Policy: Sustainable Agricultural Development in Hong Kong

The Hong Kong Bird Watching Society (HKBWS) is aware of the Government's effort in recognizing the need for a new agriculture policy and trying to promote a sustainable agricultural development in Hong Kong. We believe a true sustainability includes all three aspects of economic, social and environmental sustainability. However, we felt that the Document is not in line with the spirit of the Convention of Biological Diversity. Measures or strategies proposed mainly focused on the economic viability of agriculture development, such as promoting modernization of agriculture, establishing an 80-hectare Agri-Park for the demonstration of modern agriculture technology, and setting up of a Sustainable Agricultural Development Fund; while the conservation of biodiversity and arable agriculture land, and the sustainable use of natural resources for future generations were neglected. In order to implement a comprehensive sustainable agriculture policy in Hong Kong, we consider that the Document, current Government policies and existing legislations should be revised and amended. Below are our detailed concerns and comments regarding the Document and the sustainable agriculture development of Hong Kong.

# 1 Inconsistency in Government Policies and Loopholes in Existing Legislations

## 1.1 <u>Convention on Biological Diversity (CBD)</u>

Sustainable Agriculture is strongly related to the CBD and the principles of the Convention should be used as the backbone of the Agriculture Policy.

The objectives of the Convention are "the conservation of biological diversity, the sustainable use of its components and the fair and equitable sharing of the benefits arising out of the utilization of genetic resources"1. This international treaty was extended to Hong Kong on 9 May 2011, and the Government started to formulate the Biodiversity Strategy and Action Plan (BSAP) for Hong Kong in early 2013 to conserve the local biodiversity based on the principles of the Convention. A Steering Committee and three Working Groups (Terrestrial Biodiversity Working Group, Marine Biodiversity Working Group, and Mainstreaming and Sustainability Working Group) were set up to develop the BSAP. As stated in the 2015 Policy Address<sup>2</sup>, the Government is "...formulating the first Biodiversity Strategy and Action Plan for Hong Kong with a view to stepping up conservation efforts and supporting the sustainable development of Hong Kong in the next five years". A public consultation on the draft BSAP is expected to commence in the first half of 2015.

Aichi Target 7 of the CBD stated that "By 2020 areas under agriculture, aquaculture and forestry are managed sustainably, ensuring conservation of biodiversity". This clearly illustrates that sustainable agriculture coheres with the principle of the CBD. Yet, CBD was not mentioned in the Document. Biodiversity was only mentioned in Section 3.6 of the Document as one of the benefits of sustaining agriculture in Hong Kong, which is "...it (society) may benefit the conservation of natural resources and enrichment of biodiversity, enabling us to pass on a healthy and diverse ecological environment to our future generations".

The Government, together with local representatives and expertise, has been putting a lot of effort in drafting the BSAP of Hong Kong. The elements of biodiversity conservation within the Document should be strengthen (e.g., conservation of biodiversity in farmland through protection of arable agriculture land, implementation of conservation management schemes, and adaptation of eco-friendly farming practices), and the CBD principles should be used as the backbone of the New Agriculture Policy in order to achieve sustainable development of agriculture.

### 1.2 <u>Land Supply Strategies</u>

To avoid further reduction of farmland, all developments on arable agricultural lands in Hong Kong, including those zoned as AGR and GB, should be reviewed and the current land supply strategies should be revised.

In the 2015 Policy Address<sup>3</sup>, it mentioned that "<u>To better use agricultural land</u> now mainly used for industrial purposes or temporary storage, <u>or which is deserted</u>, the Government will continue to review a total of about 257 hectares of such sites in North District and Yuen Long with a view to ascertaining the feasibility of and scale <u>for residential development on these sites</u>. In this connection, Kwu Tung South, Yuen Long South and Fanling/Sheung Shui Area 30 have been identified for planning and engineering studies". A lot of arable agricultural land or "Agriculture" (AGR) zoned land are already lost due to various development projects, such as the North East New Territories New Development Area (NDA), Hung Shui Kiu NDA and the Land Use Review in Kam Tin South. Moreover, under the two stages of Green Belt (GB) review by the Planning Department <sup>4</sup>, well-vegetated GB zoned lands will be lost to housing developments. These areas are also potential farmlands which are also likely suitable for cultivation.

In Section 4.19 of the Document, it said that "farmers who are displaced by Government development projects will continue to be subject to the prevailing policy on compensation and rehousing. If they wish to relocate to the Agri-Park and accept the terms and conditions as laid down by the management of the Agri-Park, they will be charged rent at prevailing market rate for farmland". Compensation will be given to farmers affected by development projects, but no concrete measures were proposed to halt the loss of arable agriculture land to development. HKWBS considers that all developments on arable agricultural land in Hong Kong, including those zoned as AGR and GB, should be reviewed. The current strategy of releasing land supply should be changed; brownfields and paved lands in urban areas should have the priority to be developed first.

#### 1.3 <u>Insufficient protection of agriculture land under existing legislation</u>

The Town Planning Ordinance and related legislations should be amended to protect the existing 4,523 hectares of agriculture lands in Hong Kong and to ensure land with AGR zoning are used for cultivation only.

Under the Town Planning Ordinance, there are many uses in the AGR zoning which are not related to cultivation. They are either always permitted or permitted through application to the Town Planning Board (TPB) (Table 1). According to the data and information obtained from the Planning Department, Hong Kong SAR Government's Statutory Planning Portal 2 and minutes of TPB meetings, we roughly estimated that planning applications of a total area of 158 hectares of AGR zoned land were received by TPB between 2009 and 2013, and among them, 106 hectares of AGR land were approved<sup>5</sup>. In the same period, approximately 525 planning applications related to New Territories Exempted Houses (NTEHs) or Houses were received by the TPB, and 343 of them were approved with conditions; it can be said that the approval rate is approximately 65%. Given such a high approval rate, it creates an enormous gap between the land value for development (i.e., NTEHs, housing development, or temporary open storage) and that for cultivation. This also generates false hopes to land owners, leading to paving or dumping of soil/construction waste on AGR land, thus a loss of arable AGR land. Furthermore, hobby farms or leisure farms (under Column 2 uses), are loosely regulated, resulting in more paved areas and less cultivated land.

In the Document, the Government tried to address the above issues through the modernization of agriculture and strengthening the marketing and branding of local produce, but these does not close the gap of land value for development and that for farming. Even though 80 hectares of land will be resumed for the Agri-Park, no measures were proposed to adequately protect the 4,523 hectares of farmland outside the Agri-Park. With the existing loopholes in the current ordinances and legislations, AGR land will continue be under imminent development pressure, and the incremental loss of arable agriculture land will persist. Therefore, the Town Planning Board Ordinance and related legislations should be revised and amended in

order to fully protect the existing arable agriculture land in Hong Kong, and to ensure AGR zoned land are for cultivation only. Definition of some specific uses (i.e., hobby farms or leisure farms) should be clarified and standards of such uses should be set, so as to regulate the operation of these uses and avoid further loss of arable land.

## 1.4 <u>Summary</u>

All the above examples clearly demonstrate that the implementation of sustainable agriculture would not succeed if the existing loopholes in legislations are not filled and development policies are not changed. We consider that interdepartmental cooperation is necessary to conserve natural resources for sustainable agriculture and to implement the Agriculture Policy in a more comprehensive manner. Therefore, the New Agriculture Policy should not only be led by the Agriculture, Fisheries and Conservation Department under the Food and Health Bureau, other Government

departments such as Lands Department and Planning Department under the Development Bureau should also be actively involved.

#### 2 Multiple Importance of Arable Agriculture Land

The farmland of Hong Kong supports a high diversity of birds and should be of important conservation priority. It is of landscape and cultural values, and can act as wildlife movement corridors and buffers at the urban/rural interfaces.

Agriculture land is a complex mosaic of wet and dry, active and abandoned habitats. It provides shelter, roosting, breeding and foraging habitats for a wide range of fauna at different times of the year. Due to such a fluctuating combination of various habitats, agriculture land is capable of supporting a rich biodiversity. For instance, the White-throated Kingfisher Halcyon smyrnensis forages in dry and wet agriculture land, and breeds in woodland. In rice paddy fields, wet paddy fields attracts wetland dependent species (e.g., bitterns, wagtails) while dry paddy fields during harvesting periods attracts granivores (e.g., munias and buntings). Wet agricultural areas particularly attracts various Chinese Pond Heron Ardeola bacchus is often seen wetland-dependent birds. wandering around foraging in the water ditches of agriculture land. Eastern Cattle Egret Bubulcus coromandus utilizes wet agricultural areas for foraging and breeding, especially where Water Buffalos are present. Vegetable fields growing water spinach and watercress also attract pipits and wagtails. It should be noted that the bird composition of wetland dependent bird species found in wet agricultural land is different from that in the wetlands of the Deep Bay area. Although there are some overlaps in bird species found in these two habitats, agriculture land should be seen separately as a unique habitat.

According to HKBWS bird records, there are approximately 293 species of birds which mainly utilize the farmlands in Hong Kong. This constitutes 55% of the total bird species in Hong Kong<sup>6</sup> and 20% of the total bird species in China<sup>7</sup>. Among them, almost half of the species recorded (140 species) are regarded as of conservation importance (**Appendix 1**), including the globally endangered Yellow-breasted Bunting *Emberiza aureola* and the globally vulnerable Japanese

Yellow Bunting *Emberiza sulphurata*<sup>8</sup>. This indicates that the farmland in Hong Kong supports a high diversity of birds and is of conservation importance.

According to a recent assessment of the Bird sub-group under the Status and Trend and Red List Focus Group of BSAP, it stated that "results vary for species of farmland and open country species, with some doing well and others showing declines. Development pressure in the New Territories suggests a negative trend in the future for these species". Woodland species and wetland species are relatively well protected as these habitats are mostly within Country Parks or the Deep Bay Ramsar Site. However, as explained in the previous section, agriculture land in Hong Kong are currently not well-protected under the existing legislations and the New Agriculture Policy does not offer much protection either; under this circumstances, bird species of farmland and open country are threatened due to continual loss of habitats.

Some abandoned dry agriculture lands may seem to have relatively low ecological value, yet they may be habitats suitable for other wildlife (e.g., butterflies). These vegetated areas can act as wildlife corridors, allowing movements of wildlife between the fragmented landscapes or between separated conservation areas/country parks. Agriculture lands are also of landscape and cultural values. They can be open spaces within an urbanized area, buffer zones at urban/rural interfaces, and buffers for the protection of streams, woodlands and conservation areas. In order to implement sustainable agriculture, arable land must be conserved for cultivation and all the multiple values/functions/importance of agriculture land must be recognized in the context of ecological conservation and town planning.

#### 3 Conservation Management of Agriculture Land

Through the establishment of eco-friendly management schemes, farmers/land owners, the community and the environment can all benefit from the multiple values and functions of agriculture land.

Besides protecting agriculture land for cultivation purposes, the management of farmland and the farming practices adopted are also vital for conserving biodiversity and sustainable agriculture. Suitable management schemes are necessary to avoid the depletion and pollution (i.e., caused by the use of pesticides, herbicides and insecticides) of water and soil resources, which are the basic elements of agriculture. Under the New Nature Conservation Policy, the Management Agreement (MA) scheme has been providing incentives for local farmers/land owners to cooperate with Environmental NGOs to adopt eco-friendly farming practices for the conservation of biodiversity in agriculture land. The HKBWS (and later together with the Conservancy Association) has been implementing wetland conservation and management projects in Long Valley, and has been monitoring the bird populations in the area since the start of the project in 2005. It has been proven that the abundance and diversity of the bird community have benefited from these projects. For example, the number of globally endangered Yellow-breasted Bunting started to increase and reached the high of 68 individuals in 2014. These farmlands can be used for public education, and to strengthen the connection between the farmers and the local community. With the help of local NGOs, the produce from these eco-friendly farmlands can be re-branded and sold at a higher price to increase the income of farmers. The efforts of the farmers can also be recognized through these activities.

Conservation of farmland biodiversity cannot be done effectively without the consent and participation of farmers and land owners, thus it is important to involve the local farming community in protecting and managing their sites. Therefore, a practical way to promote eco-agriculture is to connect farmers/land owners and NGOs through the establishment of eco-friendly management schemes with subsidies from the Government. As such, a win-win-win situation can be achieved, where farmers/land owners, the community and the environment can all benefit from the multiple values of agriculture land.

#### 4 Concluding Remarks

Agriculture is not just about food safety, but also land use, development and the environment. Interdepartmental cooperation is necessary to implement the Agriculture Policy in a more comprehensive manner. On the other hand, sustainability – in terms of economic, social and environmental – is an essential element that the policy should be adhered to. The HKBWS hopes that the agriculture policy, together with the current policies and legislations, can be enhanced and revised through dialogues and discussions, and the community as a whole can work towards a sustainable future.
